ABOUT OUR ENDORSEMENTS

By affecting policy makers through electoral and non-electoral activities, Planned Parenthood Advocates of Michigan (PPAM) works every day to protect and enhance the ability of Planned Parenthood to deliver reproductive health care services in our state. We base our endorsements on voting records for incumbent candidates and a comprehensive candidate questionnaire.

- PPAM gives endorsement preference to incumbents with a 100 percent favorable voting record.
- Candidates who have no voting record shall receive an endorsement only after favorable review of their comprehensive candidate questionnaire.
- We invite all candidates, regardless of party, to return a questionnaire and apply for our endorsement. The following list of endorsements and favorable ratings are for candidates that have proactively returned questionnaires.
